

**Reciprocity Agreement**  
**Cleveland (vZOB) and Indianapolis (vZID)**  
Effective May 22, 2020

---

## Purpose

This agreement between Cleveland (vZOB) and Indianapolis (vZID) covers coordination procedures and is supplementary to the procedures in FAA JO 7110.65, VATSIM policies and procedures, and any other governing document.

## Disclaimer

Information contained herein is designed and specifically for use in a virtual air traffic control environment. It is not applicable, nor should it be referenced for live operations.

## Cancellation

vZOB and vZID Reciprocity Agreement dated September 22, 2018 is hereby cancelled.

## Mutual Automatic Visiting Privileges

- All active ZOB controllers holding a controller rating of S1 or greater, who are certified to control ZOB minor positions, shall be granted the same privileges at ZID as visiting controllers. No request will be required by the controller, as these privileges are automatic and immediate.
- All active ZID controllers holding a controller rating of S1 or greater, who are certified to control ZID minor positions, shall be granted the same privileges at ZOB as visiting controllers. No request will be required by the controller, as these privileges are automatic and immediate.
- Automatic visiting privileges shall only extend to minor facilities. Designated airspace, as defined in the VATSIM Global Ratings Policy, shall not be included in this arrangement. Controllers shall obtain major and center airspace certifications the same as any visiting controller.
- This arrangement may be terminated for specific controllers with cause by the Air Traffic Manager or Deputy Air Traffic Manager of the visiting ARTCC. The staff member initiating the termination of privileges shall notify the members' Air Traffic Manager and Deputy Air Traffic Manager of the termination. The management of the home facility shall notify the member of their termination from the program.
- This arrangement remains subject to the terms of the [VATUSA Division General Policy \(DP001\)](#).
- Controllers exercising automatic visiting privileges are not subject to any minimum visiting controller activity requirement of the visited facility.
- Controllers exercising automatic visiting privileges are responsible for ensuring they are familiar with all relevant SOPs and LOAs.

- Controllers exercising automatic visiting privileges are required to be present in the relevant ARTCC communication server, Discord or Teamspeak, while controlling. Dissemination of Discord or Teamspeak information should be limited to ARTCC controllers.
